Shri A.F.Aktaruzzaman, Scientist-E, Technical Director, NIC has briefly discussed the following points which the application software should perform.

After detailed discussion, the following resolution has been taken by the committee:

1. The entire application should be fully automated and be able to automatically update the changes as and when done as per the requirement. The application should strictly check all the rules and regulation mentioned in the Buildings Rules 2009 of NKDA and should be able to incorporate any amendments, modification and notification made by NKDA and appropriate Authority time to time.
2. The application should able to identify all the drafting error made in the drawing sheet. An error report sheet should be generated accordingly.
3. Source code for the application which will be developed for NKDA is to be handed over to NKDA at the time system go-live. Any changes in source code during the time of maintenance is to be submitted separately. It is mandatory to provide STQC certification by the bidder before go-live and whenever there is any modification in source code.
4. The payment schedule remains unchanged. No exemption will be given to the bidders in terms of Earnest Money and Security Deposit as per the order issued by Finance Department, Govt. Of West Bengal vide Order No. 4245-F(Y) dated 28th May 2013.

The meeting ended with vote of thanks to and fro from the chair of Shri Uttam Kumar.Jana, Superintending Engineer (M/E), NKDA.
