2. Bidding Procedure

The prescribed tender documents consisting of

- (i) Technical Bid and
- (ii) Financial Bid

a. Technical Bid

Technical bid should contain all the technical specifications, recommendations and other details as deem fit by the company/firm/ Organizations to evaluate their capability of undertaking work for New Town Kolkata Development Authority work with supporting document work.

b. Financial Bid

Bidders have to quote their financial offer in their letter head as per format prescribed in Financial Bid.

3. Scope of Work

- a) To understand the current building plan system and data sharing module of e-District platform.
- b) Both way communications to be made through Web XML.
- c) Data Base and File Structure with content of building plan system of NKDA to be updated once data received from e-District platform.
- d) Data to be share from NKDA server to e-District server as per the format given by the Webel via web service.
- e) Data transfer should be made secured channel in encrypted format.
- f) DWG, PDF and Other file to be share through the Web XML.
- g) These are the indicative scope of work detail to be done at the time of discussion with Webel and System Study.

4. Instructions to Bidders

- a) Registered Companies / firms/ Organizations having experience in **Software Development** are eligible to submit bid.

- b) The tender documents can be downloaded from NKDA website (<http://www.nkdamar.org>).


- c) Only enclosed formats as provided in original should be used with signature of the authorized signatory conveying acceptance of all terms and conditions of this tender.
- d) The prescribed tender document consisting of (i) Technical Bid and (ii) Financial Bid, sealed separately in two different envelopes, superscribing "Technical Bid" and "Financial Bid", and placed in a duly sealed big single envelope superscribing "**Web Service Integration with Existing Building Plan Sanction and E-District System for New Town Kolkata Development Authority, New Town , Kolkata – 700 156**", may be submitted by hand/by Speed Post to office of "**New Town Kolkata Development Authority, 03 MAR, New Town Kolkata-700156**" so as to reach within the scheduled date and time.
- e) The bidder shall quote the price of the complete project inclusive of all taxes and duties.
