1. The intending Bidder shall have to submit self attested Xerox copy of photo ID (AADHAR card) along with an application with prescribed format.
2. Bidders are to offer rate in the respective column of the application form duly signed by himself with address & self mobile number & submit the same in a sealed cover "**Bid for the Cattle vide Memo No. 1326 /NKDA/Admn-844(Part-I)/2018 Dated 22.02.2022**". Cattle ID Numbers The rate must be above Reserve price. If the rate quieted below Reserve OPrice, it will be summarily rejected.
3. Successful Bidder will have to deposit the entire amount in cash to the NKDA office authority immediately after the Bidding process is completed.
4. Lifting order of cattle will be issued after deposition of the entire Bid amount. The cattle have to be lifted within 2 (two) days from the date of issuance of the lifting order. No further time will be allowed for lifting cattle. the authority will not be responsible for the health condition of the cattle if not lifted within the stipulated 02 (two) days.
