THE NEW TOWN, KOLKATA DEVELOPMENT AUTHORITY (RECORD OF TITLE) REGULATIONS, 2011

REGULATIONS

No. 1214/NKDA/Admn.-127/2010

Kolkata, the 24th June, 2011.

In the exercise of power conferred by section 86A of the New Town, Kolkata Development Authority Act, 2007 (West Bengal Act XXX of 2007) hereinafter referred as the said Act, the Development Authority, with the previous approval of the State Government, makes the following regulations:—

1. Short title, commencement and application

- These regulations may be called the New Town, Kolkata Development Authority (Record of Title) Regulations, 2011.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. Definitions

- (1) In this regulations
 - "Act" means the New Town, Kolkata Development Authority Act, 2007 (West Bengal Act XXX of 2007);
 - b. "Form" means the Form appended to these Regulations;
 - c. "Fees" means fees payable for recording of title in the Register.
 - "Register" means a register maintained for the purpose of recording title of land, building, dwelling unit, shop, establishment or other unit situated within the area of New Town Kolkata;
 - e. "WBHIDCO Ltd." means the West Bengal Housing Infrastructure and Development Corporation Limited;

- (2) The words and expressions used in these regulations, but not defined, shall have the same meaning assigned to them in the Act:
- 3. Application for recording title:— A person shall, on getting right of title and possession of land, building, dwelling unit, shop, establishment or any other unit as specified in sub-section (1) of section 86A of the Act, apply to the Development Authority in Form A to record the same.
- 4. Notice of the transfer of title by the transferor:— Any person who transfers his title to any land, building, dwelling unit, shop, establishment and other unit situated within the area of New Town, Kolkata shall give notice to the Development Authority in Form B 1.
- 5. Notice of the transfer of title by the transferee:— Any person to whom the title of any land, building, dwelling unit, shop, establishment and other unit situated within the area of New Town, Kolkata is transferred shall give notice to the Development Authority in Form B 2.
- 6. Notice of transfer by devolution: When the title of any land, building, dwelling unit, shop, establishment and other unit situated within the area of New Town, Kolkata devolves on any person he shall give notice to the Development Authority in Form B 3.
- 7. Enclosures along with the notice:— (1) When a person gives notice under regulation 3 or 4 or 5 he shall enclose the following documents along with the relevant Form:—
 - (a) copy of allotment letter of WB HIDCO, if allotted by WB HIDCO;
 - (b) certified copy of duly registered deed of conveyance;
 - (c) photo copy of Property tax clearance receipt or certificate;
 - (d) copy of Electric Bill or Telephone Bill;
 - letter of ownership from the President/Secretary, in case of Co-operatives registered under Co-operative Societies Registration Act;
 - (f) letter of ownership from the President/Secretary, in case of Co-operatives registered under Co-operative Societies Registration Act;
 - (g) photocopy of building sanction plan;
 - (h) any other document as the Development Authority may require.
 - (2) When a person gives notice under regulation 6 he shall enclose the following documents along with Form B 3:-
 - (a) photocopy of death certificate:
 - (b) photocopy of will or testament;
 - (c) photocopy of succession certificate;
 - (d) original heirship certificate;
 - (e) up to date property tax clearance certificate.

Note:- Documents referred in clauses (b) and (c) are not to be enclosed in case of intestate succession.

8. Fee for recording the title:-

Any person who gives notice for recording the title or transfer of title shall pay a fee to the Development Authority;-

- (a) at the rate of 0.50% of the Deed value of the land or building or dwelling unit or shop or establishment or any other unit duly registered with the Registrar or Sub-Registrar appointed under the Indian Registration Act, 1908.
- (b) at the rate of 0.25% of the Deed value of the land or building or dwelling unit or shop or establishment or any other unit duly registered with the Registrar or Sub-Registrar appointed under the Indian Registration Act, 1908 in case of transfer of title by devolution.

- 9. Recording of title:— (1)Whoever applies under regulation 3 or 4 or 5 or 6 shall be called for a hearing upon serving a Notice in Form C or D as the case may be:
 - (2) All the cases shall be disposed of upon hearing .
 - (3) The Chairman or any other officer authorized by the chairman, shall take hearing.
 - (4) All cases shall either be accepted or rejected. If rejected, reason of such rejection shall be recorded in writing in the register.
 - (5) There should be recording of all accepted cases in the register and the officer who has taken hearing shall put his/her initial in the register at the appropriate column.
- 10. Maintenance of register: The Development Authority shall maintain a register in Form E for recording of title of land, building etc. under regulation 3 and it shall maintain another register for recording of transfer or devolution of title under regulation 4 or 6 in Form F.
- Issue of holding certificate: All the applicants shall be issued a holding certificate as a token of recording of
 title in the register of the Development Authority. The Development Authority shall issue such certificate in Form G.
