THE NEW TOWN, KOLKATA DEVELOPMENT AUTHORITY (CERTIFICATE FOR ENLISTMENT OF PROFESSION, TRADE AND CALLING) REGULATIONS, 2010

REGULATIONS

No. 1800-NKDA/Admn-108/2010

Kolkata, the 21st October, 2010.

In exercise of the power conferred by Section 161 of the New Town ,Kolkata Development Authority Act ,2007 (West Bengal Act XXX of 2007) (hereinafter referred to as the said Act) read with Section 36A of the said Act ,the Development Authority hereby makes, with the previous approval of the State Government, the following regulations:

1. Short title, commencement and application

- These regulations may be called the New Town, Kolkata Development Authority (Certificate for Enlistment of Profession, Trade and Calling) Regulations, 2010.
- (2) They shall come into force on and from the date of issue of the regulations, and shall be applicable for the entire areas of the New Town ,Kolkata Development Authority.

2. Definitions

- (1) In these regulations-
 - a) "Act" means the New Town ,Kolkata Development Authority Act ,2007 (West Bengal Act XXX of 2007).
 - b) "Certificate" means a certificate of enlistment for Profession, Trade and Calling.
 - c) "Fees" means the fee for purchase of application Form and fees as mentioned against each profession, trade and calling in the schedule.
 - d) "Form" means the Form appended to these regulations.
 - e) "Government" means the Government of West Bengal.
 - f) "Regulation" means a regulation of these regulations.
 - g) "Schedule "means the schedule appended to these regulations.

- (2) The words and expressions used in these regulations, but not defined, shall have the same meaning as in the Act.
- (3) The words and expressions used in these regulations and not otherwise defined, shall have the same meaning assigned to them in the West Bengal Municipal Act, 1993 (West Bengal Act XXII of 1993).

3. Submission of application for the Certificate

(1) Every person, as specified in Column (ii) of the Schedule - I, engaged or intending to be engaged in any profession, trade and calling, within the jurisdictional limits of the Development Authority, shall apply in specified Form to the Chairman of the Development Authority either by himself or by any authorised representative, for a Certificate of Enlistment;

Provided that no profession ,trade or calling referred to in sub-regulation (1) ,shall be commenced or carried on without any license or permission ,as required under any law, being obtained and produced before the Chairman or any officer authorised in his behalf ,failing which the Certificate of Enlistment shall be revoked or shall not be renewed as the case may be:

Provided further that if it is subsequently detected that the profession trade or calling is carried on without any license or permission the enlistment shall be revoked or shall not be renewed, as the case may be.

- (2) The Development Authority shall raise a demand of fee required to be deposited by the applicant as per Column (iii) of Schedule-I after making a preliminary scrutiny. The Development Authority may, by order, revise the fee annually.
- (3) An person, engaged or intending to engage for the trades as mentioned in the list of trades as appended in the Schedule -II, is required to obtain fire safety certificate from the Directorate of Fire & Emergency Services, Government of West Bengal in terms of Section 131 of the New Town, Kolkata Development Authority Act, 2007.

4. Documents required for obtaining Trade Certificate

Every person, as specified in Column (ii) of the Schedule - I, engaged or intending to be engaged in any profession, trade and calling shall submit along with the duly filled in application form, the following documents:—

- (1) Documents relating to the places of business
 - a) If the places of business is owned by the petitioner, property tax receipt is to be produced.
 - b) If the place of business is on rented premises, rent bill is to be produced.
 - c) If rent is paid through rent control, then rent control challan is to be submitted.
 - d) If a lessee, lease-deed is to be produced.
 - e) If relative/person granted rent free accommodation by the premises owner, consent letter from the owner to be produced.
 - If relative/person granted rent free accommodation by any bona fide tenant, consent letter of the tenant is to be produced.
 - g) If a sub-tenant, consent of the premises owner will also have to be produced along with documents viz. rent bills etc. of the original tenant.
 - If business is carried on or likely to be carry on at any un-assessed property, the non-assesses should submit an affidavit as per schedule-III.
- (2) In case of Companies/Private Limited Companies, the following documents are to be produced along with the application form
 - Copy of Memorandum /Articles of association.
 - ii) Copy of Declaration in Form-32 under the Companies Act, 1956.

- iii) Copy of Form-18 under the Companies Act, 1956.
- iv) Proof of occupancy.
- (3) In case of partnership firm, a copy of the Partnership deed is to be produced.
- (4) For doing business of STD/ISD/PCO, permission of the appropriate authority is to be submitted.
- (5) The permission of the competent authority is to be submitted for doing money lending business.
- (6) Branch Office of any company may be opened within the area of NKDA with due authorisation of main office.
- (7) In case of Chemist/Druggist business, permission of the appropriate authority is to be submitted.
- (8) In case of Share broking business, permission of the appropriate authority is to be submitted.
- (9) In case of Import/Export business, , permission of the appropriate authority is to be submitted.
- (10) In case of Pathological Laboratory, Clinic, Nursing Home and Hospital business ,permission of the appropriate authority is to be submitted.
- (11) In case of Cable TV business, permission of the appropriate authority is to be submitted.
- (12) In case of Ration Shop business, permission of the appropriate authority is to be submitted.
- (13) In case of hemp/opium/liquor(country/ foreign), spirit etc. business, permission of the appropriate authority is to be submitted.

4. Issue of Certificate

- (1) On payment of fee for enlistment and after such enquiry as may be necessary the application will be taken up for disposal by the Chairman of the development Authority, within 30 days from the date of receipt of the application, to issue a certificate of enlistment to the applicant concerned or to reject the application if it is not in order. The reason of such rejection shall be recorded in writing.
- (2) In the case of rejection of any application the fee for enlistment and amenities fee shall be refunded to the applicant and the reason of such rejection shall be communicated to the applicant.

5. Validity and renewal of the Certificate

- The certificate of enlistment issued under regulation 4 shall remain valid till the last day of the financial year during which the certificate is issued.
- (2) After completion of financial year ,the certificate shall have to be renewed by its holder, on submission of an application along with the renewal fee not exceeding Rs.500/-(Rupees five hundred)only for those professions, trades and calling where license fee under section 36A is more than Rs.500/-.
- (3) Renewal fee has to be paid at the rate of same rate at which an applicant is required to pay the fee for enlistment U/S 36A for those professions ,trades and calling where license fee is less than Rs,500/-.
- (4) An enlistment may be renewed within 15 days after its expiry without any late fine.
- (5) A fine amounting to half of the fee for enlistment will be charged if the enlistment is renewed after 15 days and within 60 days of the date of its expiry.
- (6) All enlistments shall be deemed to be cancelled if not renewed within 60 days of its expiry.

6. Penalty for contravention

Any contravention of these regulations shall be dealt in terms of Section 164 of the Act.
