3. Scope of Work

1. Comprehensive Coverage: The maintenance contract shall be comprehensive in nature.
2. Repair and Replacement: The AMC includes the immediate replacement and/or repairing of critical components, specifically:
3. Power Supply Card for the NEOS EPABX System (except in cases of fire-induced burning).
4. EPABX CPU Card.
5. Telephone Sets and associated connectivity.
6. Intercom Handsets.
7. Exclusions: This AMC does not cover the replacement of any plastic parts in the event they are burnt.

4. Terms & Conditions

1. The proposed Rate should be inclusive of GST.
2. Preventive Maintenance to be done on monthly basis under the supervision of the respective official of NTBC. Requisite monthly report to be made duly signed by the official of NTBC and the Agency, and submitted to the respective Authority.
3. Maintenance Period: 01 (One) Year from the date of issuance of the formal Work Order.
4. NKDA has the right to Accept or Reject any of the Quotation(s) received without assigning any reason whatsoever and that shall be final and binding.
5. Any Corrigendum or Notification in connection to this NIQ will be published in the Official Website of NKDA (www.nkdamar.org) and will also be a part of the NIQ. The Applicants are requested to follow the Website for such Corrigendum or Notification.
6. Mandatory Documents: Applicants must submit necessary copies of the following documents along with their tender document, duly signed and stamped:
 - a. Valid Trade License
 - b. PAN Card
 - c. GST Registration Certificate
 - d. Work experience for AMC of EPABX System of at least 01 (One) year in last preceding 05 (Five) in any Government Organisation. A satisfactory completion certification is to be submitted. Value of the completion work should be less than ₹ 15,000/-.
